President Biden's Bipartisan Infrastructure Law is Delivering in Wyoming

As of November 2022

The Biden-Harris Administration has hit the ground running to implement the Bipartisan Infrastructure Law, and it is already delivering results for the people of Wyoming. To date, \$2.3 billion in Bipartisan Infrastructure Law funding has been announced and is headed to Wyoming with 70 specific projects identified for funding. Since the Bipartisan Infrastructure Law passed, Wyoming is set to receive more than \$814 million for transportation to invest in roads, bridges, public transit, ports and airports and over \$72 million for clean water. And, as of today, more than 12,300 households across the state are receiving affordable internet due to the Bipartisan Infrastructure Law. Many more projects will be added in the coming months, as funding opportunities become grant awards and as formula funds become specific projects. By reaching communities all across Wyoming – including rural communities and historically underserved populations – the law makes critical investments that will improve lives for Wyomingites and position the state for success.

**Roads and Bridges:** In Wyoming, there are 218 bridges and over 380 miles of highway in poor condition. The Bipartisan Infrastructure Law will rebuild our roads and includes the single largest dedicated bridge investment since the construction of the interstate highway system. Based on formula funding alone, Wyoming is expected to receive approximately \$2 billion over five years in federal funding for highways and bridges.

- **Announced funding to date:** To date, \$778 million has been announced in Wyoming for roads, bridges, roadway safety, and major projects. This includes:
  - \$686 million in highway formula funding and \$90 million in dedicated formula funding for bridges in 2022 and 2023.
  - \$1.8 million through the RAISE program.

**Internet:** High-speed internet is necessary for Americans to do their jobs, participate in school, access health care, and stay connected. Yet nearly 22% of Wyomingites do not have an internet subscription. The Bipartisan Infrastructure Law invests \$65 billion to provide affordable, high-speed internet to every American. Wyoming will receive a minimum allocation of at least \$100 million to help ensure high-speed internet coverage across the state. Additionally, experts estimate that as many as 79,000 households in Wyoming are eligible for the Affordable Connectivity Program, which cuts internet bills by up to \$30 per month, or \$75 for households on Tribal lands, and provides a one-time \$100 discount off a connected device. The Biden-Harris Administration is providing further cost savings by working with internet providers to offer high-speed internet plans that are fully covered by the Affordable Connectivity Program — meaning most eligible households can now get high-speed internet without paying a dime.

• **Progress to date:** About 12,300 households in Wyoming are enrolled in the Affordable Connectivity Program, with more signing up every day. Households can check their eligibility, sign up, and find fully covered internet plans at <u>GetInternet.gov</u>.

**Water:** Currently, up to 10 million American households across the country connect to water through lead pipes and lack access to clean, safe drinking water. The Bipartisan Infrastructure Law represents the largest investment in clean drinking water in American history, including the first-ever dedicated federal funding to replace lead service lines and address dangerous PFAS chemicals.

- Announced funding to date: To date, \$64.6 million has been announced to Wyoming to provide clean and safe water across the state and improve water infrastructure. This includes:
  - \$63 million available in fiscal year 2022 to provide clean and safe water across the state through the Environmental Protection Agency. Of this funding, \$28.4 million is dedicated to lead pipe and service line replacement, with another \$18 million for safe drinking water investments that can also support lead pipe replacement in fiscal year 2022.

**Public Transit:** The Bipartisan Infrastructure Law makes the largest investment in public transit in U.S. history. Based on formula funding alone, Wyoming would expect to receive more than \$90 million over five years under the Bipartisan Infrastructure Law to improve public transit across the state.<sup>1</sup>This funding will expand healthy, sustainable transportation options in Wyoming, where non-White households are 1.2 times more likely to commute via public transportation and 34% of transit vehicles in the state are currently past useful life.

• **Announced funding to date:** To date, Wyoming has been allocated \$18 million to improve public transportation options across the state in fiscal year 2022.

**Clean Buses:** The Bipartisan Infrastructure Law invests over \$10 billion for clean public transit and school buses. This includes a \$5 billion investment over the next five years to replace existing school buses with zero-emission and low-emission models. Use of clean school buses promotes cleaner air, reduced health risks, especially for children, and reduced greenhouse gas emissions. This year alone, funding from the Bipartisan Infrastructure Law will help double the number of clean public transit buses on America's roads.

• **Announced funding to date**: To date, Wyoming has been awarded \$203,000 for the Environmental Protection Agency's Clean School Bus Program.

**Electric Vehicle Charging:** The Bipartisan Infrastructure Law invests \$7.5 billion to build the first-ever national network of electric vehicle chargers in the United States and is a critical element of President Biden's plan to address the climate crisis and support domestic manufacturing jobs. Through the National Electric Vehicle Infrastructure Program alone, Wyoming should expect to receive more than \$27 million in formula funding over five years to support the expansion of electric vehicle charging in the state.

• **Announced funding to date:** Wyoming has been allocated \$9.7 million in 2022 and 2023 to build out a network of EV chargers across the state.

**Clean Energy & Power:** Power outages cost the U.S. economy more than \$70 billion annually. The Bipartisan Infrastructure Law makes a historic investment to upgrade our power infrastructure by making the grid more resilient and building thousands of miles of new transmission lines to deliver clean, affordable electricity. The law also makes a historic investment in clean energy technologies like advanced nuclear, clean hydrogen, and carbon capture, as well as a historic \$3.5 billion investment in weatherization to lower energy costs for families while improving energy efficiency of homes.

- Announced funding to date: To date, approximately \$1.3 billion has been allocated to Wyoming for clean energy, energy efficiency, and power in 2022. This includes:
  - \$7.6 million for weatherization;
  - \$3.5 million through the State Energy Program;
  - \$4.5 million to prevent outages and make the power grid more resilient.
    Additional grid funding will be made available in the coming months.

**Airports:** According to some rankings, no U.S. airports rank in the top 25 of airports worldwide. The Bipartisan Infrastructure Law invests \$25 billion in airports to replace and modernize airport infrastructure, which helps the US become more economically competitive globally, creates good jobs, and revitalizes and supports more efficient and enhances traveler experience.

• **Announced funding to date:** To date, Wyoming has received more than \$23 million in 2022 for airports.

**Ports and Waterways:** Like airports, our ports and waterways are in need of repair and reimagination. The Bipartisan Infrastructure Law invests \$17 billion in port infrastructure to strengthen our supply chains, address maintenance backlogs, and reduce congestion and emissions near ports– ultimately helping our country move goods more quickly and at lower cost.

**Resilience:** Millions of Americans feel the effects of climate change and extreme weather every day. More frequent hurricanes, wildfires, heat waves, and floods, unprecedented power outages, and persistent droughts devastate our communities and threaten our infrastructure. In the last decade, Wyoming has experienced 17 extreme weather events, costing the state up to \$5 billion in damages. The Bipartisan Infrastructure Law makes a historic investment to bolster our resilience against pressing challenges like impacts of climate change, extreme weather events, and other hazards like cyberattacks.

• Announced funding to date: To date, approximately \$26.2 million has been allocated to Wyoming for infrastructure resilience in 2022 including \$4.9 million through the Army Corps of Engineers for flood mitigation.

**Legacy Pollution Cleanup:** Across the country, thousands of former industrial, chemical, and energy sites emit harmful pollutants into surrounding communities. These sites pose harms to health, welfare, and economic prosperity — and disproportionately impact communities of color: 26% of Black Americans and 29% of Hispanic Americans live within 3 miles of a Superfund site, a higher percentage than for Americans overall. The Bipartisan Infrastructure Law will deliver the largest investment in tackling legacy pollution in American history by cleaning up Superfund and brownfield sites, reclaiming abandoned mines, and capping orphaned oil and gas wells.

• **Announced funding to date:** To date, more than \$45 million has been allocated to Wyoming in 2022 for capping orphaned oil and gas wells and reclaiming abandoned mine lands and \$2.5 million has been allocated to cleaning up Superfund and brownfield sites.

#### Clean Energy Project Spotlight

#### TerraPower Kemmerer Reactor Demonstration

Overview: The Bipartisan Infrastructure Law provided \$1.3 billion under the Advanced Reactor Demonstration Program for TerraPower to demonstrate a sodium-cooled fast reactor that will advance low-emissions clean energy to power the nation's electrical grid.

#### Airport Project Spotlight

#### **Jackson Hole Airport Terminal Improvement**

Overview: The Jackson Hole airport received an \$8 million grant from DOT's Federal Aviation Administration for projects to improve the terminal building and provide new geo thermal heating to increase energy efficiency. This project will also increase capacity to meet growing demand by adding two new gates and enhance the experience of travelers, reduce delays, and increase accessibility of the airport for families.

#### **Owl Creek Irrigation District**

Overview: The Department of Interior awarded \$2 million to the Owl Creek Irrigation District to improve drought resilience, and efficient water use and delivery through WaterSMART and Energy Efficiency Grants.

## **RAISE Grant Program Project Spotlight**

#### Lincoln County Rural Planning Project

Overview: This \$1.8 million project, funded by the Department of Transportation, will develop a plan to improve several aspects of transportation in Wyoming including upgrading their freight rail system, providing electric vehicle charging stations, and improving public transit. The project will find areas ripe for freight rail access, determine optimum locations for electric vehicle charging stations, and study the addition of public transit for the rural area. The project will promote safety by shifting freight delivery from trucks to rail, reducing fatalities and injuries on the local highways.

#### **Owl Creek Irrigation District**

Overview: Teton School District #1 will be receiving a rebate of \$203,000 in order to fund the purchase of a new, electric school bus. This grant was administered by the U.S. Environmental Protection Agency and aims lower fuel costs as well as emissions exposures for students of Grand Teton #1 School District.
