Appendix A: Violations

As discussed in Chapter 2, OMB reports two categories of violations of the Paperwork Reduction Act: (1) collections in use without OMB approval and (2) lapses in renewal or discontinuation. Violations falling under the first category, collections in use without OMB approval, occur when the agency fails to submit the information collection request to OMB before it begins to collect information. Violations falling under the second category, lapses in renewal or discontinuation, occur when the agency fails to submit its request to OMB to renew (or discontinue) its approval for a collection prior to the expiration date. \(^1\)

OMB identifies three types of lapses in renewal or discontinuation: (1) all collections that expired during the given fiscal year and were reinstated after the expiration date during that fiscal year; (2) collections that expired in previous fiscal years and were reinstated during the given fiscal year; and (3) collections that expired during the fiscal year and were not renewed or discontinued before the expiration date in the same fiscal year. OMB reports the list of FY 2018, FY 2019, FY 2020 and FY 2021 violations below.
