



"Russian actors are trying harder and harder to hide who they are and being more and more deceptive to conceal their operations," said Facebook's Head of Cybersecurity Policy Nathaniel Gleicher in an interview with NPR. "But there was very little attention paid to this operation."

Facebook said the Russian agents set up a site posing as an independent news outlet and managed to recruit "unwitting freelance journalists" to write stories that were shared by dozens of social media accounts created through artificial intelligence.

On Facebook, the stories from the pseudo news site were posted to groups that appeal to progressive causes.

"It was very much a strongly left-leaning constituency they were aiming at. It looks like that was audience-building," Ben Nimmo, head of investigations at research firm Graphika, which analyzed the operation, said in an interview with NPR. "But there were indeed pieces that said Biden and Harris are much too far to the right."

- 2019 Senate Intelligence Committee report:
 - "Bad actors will continue to try to weaponize the scale and reach of social media platforms to erode public confidence and foster chaos. The Russian playbook is out in the open... and their techniques will only get more sophisticated."
- Robert Mueller, July 2019:
 - "they're doing it as we sit here."

ChatGPT



Examples

"Explain quantum computing in simple terms" →

"Got any creative ideas for a 10 year old's birthday?" →

"How do I make an HTTP request in Javascript?" →



Capabilities

Remembers what user said earlier in the conversation

Allows user to provide follow-up corrections

Trained to decline inappropriate requests



Limitations

May occasionally generate incorrect information

May occasionally produce harmful instructions or biased content

Limited knowledge of world and events after 2021

I hope this letter finds you well. I would first like to thank you for the job you've done in representing us in this time of national turmoil. The pandemic and social unrest sweeping the nation right now have made life difficult for all, and many citizens, myself included, fear that our Second Amendment right to firearm ownership may become more and more of a necessity in daily life.






