President Biden's Bipartisan Infrastructure Law is Delivering in Communities Across the County

As of November 6, 2023

High-speed internet is necessary for Americans to do their jobs, participate in school, access health care, and stay connected to loved ones. Yet millions of Americans can't afford the cost of a monthly internet connection—if they have access to a connection at all. The Biden-Harris Administration is committed to ensuring that everyone in America has access to affordable, reliable high-speed internet by the end of the decade. The centerpiece of the Administration's work to lower costs is the Affordable Connectivity Program, which provides eligible households with up to **\$30** off their monthly internet bill, or up to **\$75** on qualifying Tribal Lands. And because the Biden-Harris Administration worked with internet providers to offer high-speed internet plans that are fully covered by the Affordable Connectivity Program, most eligible households can now get high-speed internet at no cost.

Households can check their eligibility, sign up, and find fully covered internet plans at [GetInternet.gov](https://www.getinternet.gov).

More than **21 million households** are now enrolled in this critical program, and more enroll every day. **That includes over 800,000 veterans, 5 million seniors, 3.1 million families with a K-12 student receiving free or reduced-price lunch, and a million low-income college students.** The Biden-Harris Administration is calling on Congress to renew funding for the Affordable Connectivity Program through 2024, so that millions of Americans don't lose access to the internet and the economic opportunities that come with it.
