## STATEMENT OF ADMINISTRATION POLICY

### **H.R. 7147 – Homeland Security Appropriation Act, 2026**

### **H.R. 7148 – Consolidated Appropriations Act, 2026**

(Rep. Cole, R-OK)

The Administration supports the passage of H.R. 7147, which makes appropriations for the Department of Homeland Security for the fiscal year (FY) ending September 30, 2026, and H.R. 7148, which makes appropriations for Defense; Labor, Health and Human Services, and Education; and Transportation and Housing and Urban Development for the FY ending September 30, 2026. The Administration is pleased that the Congress is completing the appropriations process in a manner that avoids a bloated omnibus package and adheres to a fiscally responsible topline agreement that *decreases* overall discretionary spending, while making key investments in Administration priorities.

H.R. 7147 supports President Trump's successful border security agenda, which has led to border crossings falling to a record low, eight consecutive months of zero releases at the border, and the mass removal of criminal aliens from the United States. Importantly, this measure includes no new restrictions that would impede the Administration's success to date. H.R. 7147 also eliminates funding for the shelter and services program, which funneled money to non-governmental organizations facilitating the border crisis in the past, and eliminates funding for the Office of Immigration Detention Ombudsman, which previously harassed Immigration and Customs Enforcement. The bill also provides key support to the Coast Guard, United States Secret Service, and other entities responsible for protecting the homeland.

H.R. 7148 provides critical funding to the Department of War to deter threats and fully funds a 3.8 percent pay raise for U.S. troops. The bill makes critical investments in lethality and robustly supports the revitalization of U.S. shipbuilding. Further, it provides multiyear procurement authority for certain critical munitions. The Administration appreciates this provision and looks forward to continuing to work with the Congress moving forward to ensure that critical munitions needs are met.

Importantly, H.R. 7148 builds on the successes of the President's rescissions package by providing no further funding to the woke Corporation for Public Broadcasting, which previously subsidized radical and biased programming at entities like National Public Radio and the Public Broadcasting Service at the taxpayers' expense. The bill also supports air traffic controllers and President Trump's efforts to modernize the Nation's air traffic control system. Finally, the bill

designates the Melania Trump Foster Youth to Independence Initiative within the Department of Housing and Urban Development to support America's foster youth.

The Administration urges the Congress to support these fiscally responsible measures and complete the FY 2026 appropriations process, thereby avoiding another disastrous Government shutdown.

If these bills were presented to the President in their current form, his senior advisors would recommend that he sign them into law.
